

# Privacy Policy for the HUSTY Mobile Application

1. Your personal data administrator is Husty M.Styczeń, J.Hupert sp. j. registered in Krakow [ul. Rzepakowa 5E, 31-989 Kraków, entered in the Register of Entrepreneurs kept by the District Court for Kraków-Śródmieście District in Krakow, 9th Commercial Department of the National Court Register, entry no. KRS 91562, Tax ID No. NIP 6770082043, Business Statistical No. REGON 350690189 (“the Administrator”)]; the Administrator’s contact details: [info@husty.pl](mailto:info@husty.pl) Tel. +48(012) 645-03-04; fax +48(012) 645-03-33.
2. The Administrator has not appointed the Personal Data Protection Inspector.
3. Be informed that your personal data is processed for the purpose of registration in the HUSTY mobile application and for the purpose of keeping your account created in the application. Your email address given during your registration in the application is required, in particular, to log into the application and recover your lost or forgotten password. Furthermore, notifications about devices linked to your account shall be emailed to your email address.
4. Your personal data is processed on the basis of your voluntarily given consent, constituting the premise legalising personal data processing in accordance with the provisions of art. 6 item 1a of the Regulation (EU) on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation - the GDPR).
5. It is a contractual requirement to have your personal data in the HUSTY mobile application. You are not obligated to enter or otherwise give us your personal data; however, it is not possible to register in the HUSTY mobile application without entering your personal data.
6. Your personal data entered in the registration form shall be transferred to hosting companies responsible for ensuring appropriate and adequate technological and organisational measures in place as required by the GDPR. Neither the Administrator nor the hosting companies working with the Administrator shall hand over, transfer or otherwise make your data available to any third countries (i.e. any countries outside the European Union).
7. Your personal data shall be kept for the duration of your keeping your account in the database for the HUSTY application and removed without a delay after your account is closed or removed.

9. Be informed that you have the right to:
  1. request access to your personal data from the Administrator;
  2. when the personal data processed by the Administrator is incorrect, you have the right to correct, change, amend or modify it;
  3. in the case when the Administrator does not need your personal data for the purpose for which it has been collected as well as when the data should be removed to comply with applicable laws or the data has been collected further to provision of services offered electronically to a child, you have the right to request removal of your personal data by the Administrator;
  4. in case when you question correctness of the personal data processed by the Administrator, you may request to have its processing limited for the period allowing the Administrator to verify correctness of the data;
  5. to request a transfer of you personal data which you may specify.
